# **OVERVIEW:**

This annotated bibliography presents a rough overview of global academic English literature from 2015-2018 in four areas: migration, immigration, citizenship and refugees. These four terms were u used to find academic journal articles on the EBSCOhost Database, obtained through the University of Alberta library system. Article abstracts are presented by geographic focus of the research, with a focus on world region. Additional keywords are provided at the beginning of each region followed by a short summary is provided to review the major findings. The annotations have either been adapted or drawn from the Database and/or authors' abstracts. The articles are mostly from North American, Australian and European journals and only academic articles are included in this bibliography. This bibliography is not an exhaustive list and there may be relevant articles and other materials that are not listed here.

# 1. Asia

#### **Summary:**

The following articles about Asia cover subjects like policy, economy, and law as they relate to issues surrounding migration. Most of the articles focus on Central or Western Asia, with a few exceptions that highlight Southern Asia, South-eastern Asia and Eastern Asia.

Most of the articles below describe the issue of migration and integration in Asia itself and its changing character. In addition, some articles refer to Russia and the combined continental landmass of Europe and Asia, that is Eurasia. The primary topics concern the relationship between major powers; policy challenges presented by migration; the connection between diplomatic strategies and government policies; and, regulatory regimes that control migration. Some articles also discuss medical infrastructure and whether or not, or to what degree, healthcare is available for migrants.

The keywords "policy" and "economy" are used most in connection to "migration, immigration, citizenship and refugees" in Asia.

# 2. Africa

#### **Summary:**

The following articles about Africa cover subjects like security, urbanization, and the economy as they relate to issues surrounding migration. Most of the articles focus on Southern Africa, and specifically South Africa. Articles related to Sub-Saharan Africa are listed in a separate sub-section.

Largely, the articles below address the lack of security in terms of migration. Many articles cover issues like violence, criminalization, corruption, terrorism, war, drug-trafficking, smugglers, and a lack of appropriate laws and legislation by governments to address these issues. Some articles discuss the aim of African governments to work together or to cooperate with other governments around the world to find solutions for several problems, like poverty and emigration. Approximately 1/3 of the articles were related to emigration to European countries, while 2/3 discuss migration within Africa. In fact, one article notes that that Sub-Saharan Africa is the region that hosts the largest population of refugees in the world.

The keywords "security" and "law" are used most in connection to "migration, immigration, citizenship and refugees" in Africa.

# 5. Europe

#### **Summary:**

Many of the recent academic articles concerning Europe and migration mostly focus on the so-called Migration Crisis of 2015/16 (hereafter referred to as "MC15/16). They also cover European policy, experimental research and law, especially at borders, in relation to issues surrounding migration. Of regions covered in this annotated bibliography, the one pertaining to Europe is the largest. Within Europe, work pertaining to Eastern and Western Europe covers is comparatively large. As much work covers the continent as a whole a well as the European Union, there are separate headings covering "Europe in general" and the "European Union in general". However, it should be noted, that there are also articles in the other sections on issues relating to the EU and Europe.

Overall the issue that is most reported about is the European Migration Crisis in 2015 and 2016 and how different states and publics dealt with this issue, and what the future portends. As a body this work provides discussions relating to border control, statistics about the number of refugees, laws of the European Union (like the Dublin Regulation) and the contradictory and

conflicted responses by the governments toward helping refugees. Additionally, a secondary focus is on the growing strength of right-wing parties (like the AFD in Germany) in connection to the (still current) migration issue in Europe, as well as increasing party competition. It is notable that many articles about right-wing parties also cover issues like diversity, discrimination and racism. Both immigration and refugees are portrayed negatively and form a major emphasis in the in party programmes and statements of right-wing parties. #### **Summary:**

More specifically, most of the articles refer to Australia's government, including different laws, recent changes in policy, as well as foreign relations (e.g. with Italy, Indonesia, the U.S.). Some articles cover Oceania's history with a focus on the migration of displaced persons after the Second World War. Others examine the impact of climate change on migration, as well as gender for example by focusing on Indian women migrants in Australia or refugee men in Queensland. Issues of security and the fragility of the Melanesia and Micronesia governments are important topics in articles covering migration in those regions. Finally, climate change is repeatedly referenced as an pressing problem, and source of migration, especially in the area of Polynesia.
